AND WHEREAS Section 28(3) of the *Planning Act*, R.S.O. 1990, c. P.13, as amended (the "*Planning Act*") confers on the Township the power to acquire land within the community improvement project area where a by-law has been passed under Section 28(2) of the *Planning Act*.

AND WHEREAS Section 6 of the *Municipal Act* confers on the Township the power to expropriate land in accordance with the *Expropriations Act*, R.S.O. 1990, c. E.26, as amended;

NOW THEREFORE The Council of The Corporation of the Township of Uxbridge hereby enacts as follows:

- 1. That the Council of the Corporation of the Township of Uxbridge hereby approves the making of an Application for Approval to Expropriate the Subject Lands by the Corporation of the Township of Uxbridge for the purposes of economic and social development of Downtown Uxbridge in furtherance of the Township's Downtown Community Improvement Plan, the Township's Official Plan, the 2020 Downtown Uxbridge Vision, and all activities ancillary thereto.
- 2. That an Application for Approval to Expropriate Land be made by the Township in respect of the Subject Lands and that an Application be executed by the Mayor

and Director of Legislative Services & Township Clerk, attached as **Schedule** "A".


- 3. That a Notice of Application for Approval to Expropriate Land be executed on behalf of the Township by the Mayor and Director of Legislative Services & Township Clerk, attached as **Schedule "B"**, and that the Notice be served and published in accordance with the *Expropriations Act*, R.S.O. 1990, c. E.26, as amended (the "*Expropriations Act*").
- 4. That the Director of Legislative Services & Township Clerk be authorized to forward to the Ontario Land Tribunal (the "OLT") any requests for an inquiry that are received, and that the Township be represented at any such inquiry ("Hearing of Necessity") or proceeding held under the Expropriations Act.
- 5. That Staff report back to Council in the event a report is received from the OLT pursuant to any Hearing of Necessity held under the *Expropriations Act*.
- 6. That Staff report back to Council for approval to expropriate the Subject Lands where no Hearing of Necessity is required, or such request is withdrawn in accordance with the *Expropriations Act*, or if an amicable transaction is negotiated with the property owners.


